The above named David Kelley and Rose Kelley, the foster parents and Eileen Mary Anger, the minor child, above named and Dennis Anger, the father of said Eileen Mary Anger, infant, having appeared before me and been examined as required by the Domestic Relations Law of the State of New York and upon reading and filing the petition of said David Kelley and Rose Kelley duly verified the 23rd day of April, 1929, and an instrument containing and substantiating the consents required by said law and agreement of said David Kelley and Rose Kelley, as foster parents to adopt and treat the said minor child as their own child and a statement of the age of the child and the new name by which said minor child shall be known having been presented to me; and the said instrument having been filed by the foster parents and by each person whose consent is necessary to the adoption before me; and it further appearing in said petition that the natural mother of said minor child is dead and that Dennis Anger is the sole surviving parent; and it further appearing to my satisfaction from the examination had by me that the moral and temporal interests of said minor child will be promoted by said adoption in securing to such child the advantages of the affection, guidance and instruction of a good home and that the said David Kelley and Rose Kelley, his wife, the foster parents are persons of good moral character and have sufficient means and are fit and proper to have the immediate care and custody of said child it is



ORDERED, ADJUDGED AND DECREED that the said adoption by David Kelley and Rose Kelley, his wife, of Eileen Mary Anger, a minor child, born on the 1st day of March, 1924, be and the same is hereby in all respects allowed and confirmed; and it is further

ORDERED, ADJUDGED AND DECREED that said minor child shall henceforth be regarded and treated in all respects as the lawful child of David Kelley and Rose Kelley, his wife, foster parents with all the rights and privileges conferred by law; and it is further

ORDERED, ADJUDGED AND DECREED that said minor child be hereafter known as Eileen Mary Kelley; and it is further

ORDERED, ADJUDGED AND DECREED that this order be filed and recorded in the office of the Clerk of the County of Erie.
